Although perception and acceptance often lag behind reality, there is evidence that a new definition of family — while far from universally accepted — is emerging.

A report this month by the Pew Research Center asked 2,691 randomly chosen adults whether seven trends were "good, bad or of no consequence to society." The trends were:

- more unmarried couples raising children
- more gay and lesbian couples raising children
- more single women <u>having</u> children without a male partner to help raise them
- more people living together without getting married
- more mothers of young children working outside the home
- ...etc.
